Degree Exam Related Provisions of the International Doctoral Program of Education and Human Development, College of Social Science, National Sun Yat-sen University

- 一、依據教育部頒「學位授予法」、本校「學則」及「研究生學位考試施行細則」
 訂定之。
- The Regulations is based on Ministry of Education Degree Conferral Law, Academic Regulations and Enforcement Rules of Postgraduates Students Degree Examinations of National Sun Yat-sen University (hereafter referred to as "NSYSU").
- 二、在學期間相關事項:
 - (一)修業年限:1至4年(不含保留入學及休學期間)。
 - (二)學分制度及課程要求:
 - 碩士班學生須修畢規定之應修科目及畢業最低學分數27學分(包含研 究方法3學分為必修)。
 - 2、 每學期修課數以12學分為上限(包含於他系所修讀之學分)。
 - 3、選修課程分為3大領域,包含「教育領域」、「教育領域應用心理學」、
 「統計學與心理計量學領域」,碩士班學生需擇一領域修讀並至少修 畢該領域3門課程。
 - 4、 畢業學分包含於他系所修讀之學分,但上限不超過10學分。
 - (三)論文指導教授選派:
 - 學生須於第一學年結束前選擇論文指導教授,並繳交「論文題目/ 論文指導教授申請表」(上學期7月31日前,下學期1月31日前)。
 - 論文指導教授須為本校教師且為本學程之授課教師,非本校教師者 可為共同指導教授。
 - 3、倘因故須更改已選定之指導教授或論文題目,必須獲得本學程同意後,始得更改。申請更改指導教授學生若已通過已論文計畫,須再 重新審查論文計畫。
 - (四)其他
 - 1. 於修業期間至少發表一篇研討會論文。

- 符合上述學分要求後並符合學位授予法有關申請為碩士學位候選
 人之他項要件者,始得成為本學程碩士學位候選人。
- 2. Relevant information during study period:
- (A) Limitations on study duration: students must complete their study within one (1) to four (4) years in accordance with regulations of Ministry of Education (MoE) and regulations for Master's Program of the university (not including the period of deferred enrolment and suspension).
- (B) Course and Credit Requirements:
- I. The postgraduates are required to complete 27 credits, including the required courses (ie, 3 credits of Research Methodology).
- II. The postgraduates shall not take more than 12 credits each semester (including the credits taken from other programs).
- III. The elective courses are divided into three (3) major areas, namely Education, Applied Psychology in Education, and Statistics & Psychometrics. Postgraduate students shall select one major area and complete at least three (3) courses in the selected major area.
- IV. The required minimum credits for graduation may be taken from other programs external to IGPEHD; however, such credits shall not be more than ten (10).
- (C) Selection of Supervisors:
- I. The postgraduates shall finalise their choices of supervisor and submit the Application Form of Dissertation Title and Supervisor by the end of their first study year (by the end 31st July in the first semester or by the end of 31st January in the second semester).
- II. Supervisor has to be IGPEHD's faculty member and co-supervisor may be selected outside from NSYSU.
- III. If the postgraduate wishes to change his or her supervisor or dissertation title, he or she must obtain IGPEHD Committee's approval before applying for the change.
- (D) Others
- I. The postgraduates shall publish at least one (1) conference paper during his or her study.
- II. The postgraduates shall become postgraduate candidates if he or she satisfies the criteria of minimum credits and Degree Conferral Law.
- 三、碩士班論文計畫書發表相關規定:

學期之定義:上學期自每年8月1日至隔年1月31日、下學期自每年2月1日至7 月31日。

- 1、 論文計畫書口試通過3個月後始得進行碩士學位口試。
- 論文計畫書須經本學程考試委員會審查及學程主任同意後,始得申請論 文口試。

3. Postgraduate dissertation proposal

Definition of semester: the fall/first semester starts from the 1st August to the next 31st January; and the spring/second semester starts from the 1st February to the next 31st July.

- (A) The postgraduates may start the postgraduate degree defence three (3) months after passing the dissertation proposal defence.
- (B) The postgraduates may apply for dissertation defence after his or her proposal is reviewed and approved by IGPEHD Examination Committee members.
- 四、論文口試:
 - 學生須修畢本學程規定之畢業最低學分數及完成以本學程名義發表1篇
 研討會論文要求,始得參加論文口試。
 - 學位考試得於「學期開始日」提出申請。學位考試應於申請之該學期學 校行事曆規定學期結束日之前舉行。
 - 3. 需於論文口試2週前繳交「論文口試申請表」。
 - 學位考試委員會至少需包含3位成員,指導教授為當然委員,學程外委員 至少1人。口試委員名單由論文指導教授推薦,但論文指導教授不得為 委員會召集人。
 - 學位考試成績根據論文及口試成績評定,通過標準以70分(含)以上為 及格,始可獲得本學程碩士學位。
 - 通過學位考試者需繳交碩士論文學位審定書,附上所有口試委員簽名。
 - 7. 學位考試成績不及格而其延長修業年限尚未屆滿者,得於次學期或次學 年舉行重考,重考以1次為限,經重考1次仍不及格者,依本校學則 規定應令退學。
 - 學位考試成績不及格而其延長修業年限尚未屆滿者,應於次學期或次學 年完成註冊。學期結束日前未通過口試,則考試失效。
 - 在完成學位考試後,若學生未能在下一學期註冊日前完成所需的課程和
 學分或達到本學程規定,則考試失效。
- 4. Dissertation Defence
- (A) The postgraduates may participate in a dissertation defence if he or she has completed the minimum credits as regulated by IGPEHD.
- (B) The postgraduates shall apply for the degree exam from the start date of the semester. The degree exam shall be held before the end of the semester as scheduled by NSYSU.
- (C) The postgraduates shall hand in the Application Form of Dissertation Defence.
- (D) IGPEHD Exam Committee shall be composed of at least three (3) members, with the supervisor of the postgraduate being the designated reviewer. There shall be at least one (1) external

reviewer outside IGPEHD. The reviewers are named by the supervisor; however, the supervisor shall not be the convener.

- (E) The postgraduate shall be conferred with Master's degree if he or she passes Degree Exam and Dissertation Defence at the score of at least 70 out 100.
- (F) The postgradutes who pass the degree exam shall hand in the Review Form of Master's Dissertation with the signatures of all the Exam Committee members.
- (G) The postgraduate who did not pass the Degree Exam and has to extend his or her study period may resit the exam in the next semester or next year. The postgraduate can only resit the exam once and discontinuation from his or her postgraduate study shall be applied, as regulated by NSYSU, if he or she fails the resit
- (H) The postgraduates who did not pass the Degree Exam and has to extend his or her study period shall complete the registration in the next semester or the next year. His or her exam results will be nullified if he or she did not pass the dissertation denfence before the end of the semester.
- (I) The postgraduates who fail to complete the required courses or the minimum credits as regulated by IGPEHD after taking the Degree Exam, the results of the Degree Exam will be nullified.

五、畢業:符合上述之各項規定者,得提出畢業之申請。

5. Graduation: the postgraduates who satisfy the aforementioned criteria may apply for graduation.

六、本規定經學程會議、院務會議通過,簽請校長核定後施行,修訂時亦同。

6. The present regulations come into force following the approval of IGPEHD and the College of Social Sciences in their meetings. The same procedure shall be carried out when amendments are to be made.
